## ***Solar Photovoltaic Building Permit Application***

All of the following items noted below shall be submitted when applying for a building permit for a Solar Photovoltaic Reviewing and processing a permit application can take up to ten business days to complete once all the required documents have been received.

*\*\*Any forms required below can be found under the forms/applications tab on my website, melstrominspections.com*

- 1** A completed and signed building permit application, backside of this page. Contractors shall be licensed.
- 2** If you are the applicant who owns the property and who currently resides at the project property address completing the permit application, a signed cautionary statement will need to be submitted.
- 3** A site plan: A site plan is a bird's eye view of your property. The site plan shall include a North directional arrow, property lines, street(s), existing buildings, and the proposed Solar PV location. To be included in the site plan shall be the distances from the proposed project to all property lines, streets, and/or any other structures on the property. \*Additionally, the locations of the array, combiner panels, ac and dc disconnects, service meter, main service panel, inverters, or any other major PV equipment components.
- 4** *A one line drawing of the installation. Included with the one-line, or part of the plans shall be conductor sizing, calculated amperages, fuse/breaker sizing, and shall indicate the type of interconnection that will be completed.*
- 5** *A label page indicating the type, verbiage and locations of the labels to be installed.*
- 6** *Spec/data sheets for the equipment being installed. Modules combiner, inverters, or other.*
